  - The attending members hoped that Sonja would offer to assist on one or more of the sub-committees.
- 4. Future issues of bylaws and structure:
  - o Defining benefits of membership
  - Voting procedures, including how to define voting members and what items the membership votes on
  - o Committee structure.

- 6. North American Same-Sex Championship:
