C. Committee Reports

to C.1.:

NASSPDA's balance of the operating account is \$7,404.12 and of the savings account earmarked for scholarship, including the additional allocated amount for 2014, is \$3,297.09.

to C.2.a.:

The next eNewsletter will be published at the end of April or beginning of May and include a blurb about the upcoming IAGLCWDC convention on Memorial Day weekend in Denver and a report and images from the 2014 April Follies, the 2014 US Championships.

to C.2.b.:

Memberships renewed or newly added online are automatically updated in the system, but need some monitoring, whereas memberships paid by cash or check need to be processed manually.

to C.2.c.:

Two registrations are so far recorded for the student membership level. New Board member, Eddie Alba, will spearhead a promotional initiative to increase that number. **to C.3.:** Approved

The Board approved the judges applications of Alex Tchassov and Scott Lappin. to C.4.a. & b.: <u>Approved</u>

Part of the scholarships for the 2014 North American Championships at the Boston Open, the Board approved to cover the "early bird" registration fee for "all-you-can-dance" at \$100.

D. Old Business

to D.1.a.i. through iii. & b.: Postponed

These agenda items are temporarily on hold until after GG9.

to D.2.a.i. through iv.: Postponed

There had been no update at the time of this meeting on any of the outstanding issues.

to D.2.b.: Postponed

There had been no update about IFSSDA at the time of this meeting.

to D.3.a.:

A bid to migrate NASSPDA's website to WordPress was received by SiteLightning Inc. at 60 hours and a rate of \$60 per hour with a maximum cap at \$3,780. There are still some questions about a needed plug-in to handle membership data, which would add a monthly \$20 fee.

to D.4.a.:

Due to declining attendance, the organizers of the PLDC decided to discontinue this competition after this year, but are possibly reconsidering.

to D.4.b.:

120 participants have so far registered for the 2014 April Follies, with many new names on the participants' list. This is a higher number than was expected and might be related to GG9. A community meeting will precede a series of workshops and will focus on questions about GG9 with Rob Smitherman, the Sports Director of GG9, in attendance that following Sunday.

to D.4.e.:

The Board's new liaison to the Boston Open, which involves ensuring adherence to NASSPDA rules and helping with any NASSPDA related issues, is Michael Winward.

to D.4.c:

Despite several reminders, NASSPDA has yet to receive a sanctioning application and invited judges any confirmation from the organizer of the Montreal's Rainbow Dance Championship.

to D.4.f.:

The 2016 North American Championships will be part of the NA Outgames in St. Louis, which leaves open the question where those will be held in 2015 as well as the US and Canadian Championships. Vancouver during the summer of 2015 might be a possibility.

to D.4.g.:

Dancesport at the World Outgames in 2017 will most likely be again the World Championships, depending at what stage IFSSDA will be at that time.

to D.4.h.:

Dancesport at these Gay Games in 2018 will also most likely be the World Championships, depending at what stage IFSSDA will be.

There were no outstanding issues or inquiries regarding NASSPDA's current competition rules.
