In contrast to the organizations BASSDA (Bay Area Same-Sex Dance Association), ESSDA (European Same-Sex Dance Association) and IFSSDA (International Federation of Same-Sex Dance Associations), NASSPDA (North American Same-Sex Partner Dance Association) has the additional distinction of "Partner" in its name. Choosing to add this word not only still causes difficulties for some pronouncing the acronym (sorry about that!), but also was the subject of long and detailed discussions by the original elected Board of Directors, along with the geographical distinction and "Same-Sex" versus "Same-Gender" or "Equality."

The founding members of NASSPDA's Board ultimately felt that "Partnering" is such an important distinction versus any other form of dancing that it should be stated in the name of its organization. It is indeed an element that is strongly considered in judging a couple's skills (even though in a Student/Teacher couple only the student should be considered in judging all skill levels). This skill is comprised of many aspects and sets "Partner Dancing," often also summarily referred to as "Ballroom Dancing," clearly apart from any other dance forms. When discussing the inclusion of "Partner" in NASSPDA's organizational name, the term "Ballroom Dancing" was also on the table, but ultimately rejected, since it often is also used to only describe what is known as "Smooth Dances" and would therefore exclude for example "Latin Dancing" and "Country Western Dancing."

In a previous eNewsletter, I had brought up the issue of NASSPDA exploring changing its name, reflecting the inclusion of all types of gender configuration in a couple. This came up when NASSPDA considered adding in its rules next to same-sex (female/female couples and male/male couples) and reverse-role (female leading a male at least 75% of the dance) events an "open" category, which would allow any configuration of a couple, in order for its sanctioned events being more inclusive. After further discussion and some responses from our constituency, it was decided that "Same-Sex" for many reasons still describes and represents for what our organization stands adequately. Though the option of an open category has been officially added to NASSPDA's Competition Rules.

Some mainstream organizations, such as USA Dance (amateur organization in the USA), NDCA (National Dance Council of America), WDC (World Dance Council, formerly International Council of Ballroom Dancing), also do not include any distinction in the name of their organization as to what form of dance it represents, and some, such as WDSF (World DanceSport Federation) or DTV (Deutscher Tanzsportverband), indicate this by including the distinction of "Dancesport," referring by definition to the competitive aspect of partner dancing. The German counterpart of NASSPDA combines in its name, DTEV (Deutscher Verband für Equalitytanzsport), the distinction of "Equality Dancing," referring to that choice of gender and lead/follow configuration in a couple isn't preconceived (set in most rules of mainstream organizations to be male leader and female follower), and the distinction of competitive partner dancing with the compound "Dancesport."

In any event, partnering and equality are without a doubt important distinctions for NASSPDA, and it will be NASSPDA's continued mission to strive for inclusion and celebration of both. Comparative judging, the norm at partner dance competitions, makes

some of this challenging, ensuring that judges keep in mind enforcing these values. NASSPDA's rules specify that "Changes of lead added to a couple's routine are considered to represent a higher degree of difficulty. If executed well, they should be reflected in a higher score and not considered a break in the continuum of the dance." That's why adjudicators invited to judge at any NASSPDA sanctioned competition are required to be approved and are asked to attend a meeting prior to the event at which the head judge reiterates these and other values important to our constituency. As with many other issues though, only time, consistent reinforcement and reexamination will ensure the full application of these important distinctions within our community.
