From the President

On the Discussion of Changing NASSPDA's Organizational Name

It is exactly 10 years ago; that three members of the Board of Directors (Barbara Zoloth, Citabria Phillips and Winter Held) signed NASSPDA's By-Laws, which define the organization along with its Mission Statement, Governance Policies and Competition Rules and which I certified as the then Secretary of NASSPDA. The following is stated in these By-Laws as to NASSPDA's purpose:

Article 2 'Purposes'

Section 1. 'Objectives and Purposes'

The primary objectives and purposes of this corporation shall be:

- (a) To support and grow the same-sex partner dance community throughout North America
- (b) To support consistent rules and objectives for same-sex partner dance competitions
- (c) To authorize the granting of state, regional, provincial, national, and North American championship titles for same-sex partner dance competitions
- (d) To encourage same-sex social dance opportunities
- (e) To provide a forum for communication within the same-sex partner dance community throughout North America, including dancers, teachers, event organizers, vendors, and other interested parties
- (f) To work towards acceptance and respect of same-sex partner dancing in the larger partner dance communities

And the following is NASSPDA's current Mission Statement, published on its website: Our Mission

The North American Same-Sex Partner Dance Association (NASSPDA) is a membership organization committed to the promotion and expansion of social and competitive same-sex partner dancing, which includes Ballroom, Latin, Swing, Country Western, and other partner dances, as well as different styles within those terms, such as International and American Style. NASSPDA acknowledges and celebrates its origins in the lesbian, gay, bisexual, and transgender community.

NASSPDA's goals are:

• Establish and continue to improve consistent definitions, guidelines and standards for same-sex partner dance competitions in North America, with an initial emphasis on those dances featured at the Gay Games and Outgames.

- Support functions and venues for social same-sex partner dancing.
- Be a resource for same-sex partner dancers.
- Aim to raise the level of same-sex partner dancing.
- Coordinate and liaison with dance organizations and sponsors of dance competitions.
- Encourage the inclusion of dancers from diverse backgrounds with regard to race, ethnicity, gender, age, [dis]ability, gender identity and/or expression.
- Encourage making same-sex dance events accessible and affordable.
- Function with a high degree of operational accountability and transparency.
- Operate according to the rules and principles of a not-for-profit organization.

The primary focus on same-sex dancing, as NASSPDA's organizational name spells out, has been continuously questioned over the years following its inception, primarily as being too limiting and not inclusive enough.

Politically, promoting the look of a same-sex couple was the initial impetus, since it redefined undeniably and with clarity what had been the only acceptable configuration of a couple in the mainstream world. As a matter of fact, the formation of NASSPDA and its European counterpart ESSDA prompted an addition to the rules of most mainstream organizations, defining a couple as a man leading a woman. Since then, some mainstream organizations, such as USA Dance, have though moved to welcoming any configuration of a couple at their events.

Recognizing the limitations to its greater constituency, NASSPDA followed the lead of BASSDA, which organizes the biggest annual event 'April Follies,' and added to its rules the possibility of an 'open' category that allows for any configuration of a couple. This addition renewed the discussion whether NASSPDA should change its name and revise its mission as well to reflect more clearly the inclusion and welcome of all dancers, as stated in the 6thbullet point of NASSPDA's mission statement.

NASSPDA's Board of Directors had a continued discussion about this issue over the years and decided this year to actively seek its constituency's opinion on a name change as well as what that would be by posting a survey on its website, on its Facebook page and distributing it at NASSPDA sanctioned events. In previous years, the consensus had been that the distinction of 'same-sex' in the organization's name was politically still relevant and important to maintain (along the lines, for example, with 'same-sex marriage'). This is still, in my opinion, a valid reason, if not only for the historical context, to keep the name untouched. It also aligns us instantly recognizable with other partner organizations, such as ESSDA, BASSDA, UKSSDC, etc., and our world umbrella organization IFSSDA.

Suggested changes of NASSPDA's organizational name have so far included substituting 'same-sex' with 'queer' or 'equality,' which, I think, are good solutions and address the issue adequately. Considering though the implications of changing NASSPDA's name on a broader scale, I also just recently asked myself what it would mean, having to rebrand and loosing, at least for a time, brand recognition, and whether there might be an alternative. This will have a financial impact, having to get a new domain name for our website, redoing all printed material, designing a new logo, getting new banners, etc. So it occurred to me that one way to circumvent this, yet still addressing the issue at hand, would be by adding a subline to our name and revise our Mission Statement reflecting even greater inclusion. For example, the organizations name could remain being 'North American Same-Sex Partner Dance Association' with the byline 'promoting gender equality in partner dancing' and substitute 'same-sex' with 'equality' or add the term to 'same-sex' in the Mission Statement.

Undeniably, times and with it definitions and sensibilities are changing, which is why we, as an organization, have the responsibility to look at the relevance of our mission and its implications in a changing world and from time to time reexamine those documents and regulations that define us. But it is also important to reflect upon and not deny the historical context that created our movement in the first place, which still defines our legitimacy.

ACTIVITY GRANT FUNDING PROGRAM

NASSPDA would like to encourage its members and our community at large to engage in various fun activities that promote same-sex dancing. We recognize that many of our members may have a creative idea and NASSPDA would like to contribute in a small financial way.

Up to 4 grants of \$250 each will be awarded per calendar year on a first-come first-served basis to applicants who can demonstrate that the proposed activity will advance NASSPDA's mission of promoting and expanding social and competitive same-sex partner dancing.

The proposed event should also be in alignment with NASSPDA's following goals:

- * Support functions and venues for social same-sex partner dancing.
- * Provide a resource for same-sex partner dancers.
- * Aim to raise the level of same-sex partner dancing
- * Encourage the inclusion of dancers from diverse backgrounds with regard to race, ethnicity, gender, age, [dis]ability, gender identity and/or expression.



Some ideas for events and organizers to receive grant support:

- Same-sex dance classes
- A social dance mixer with actively inviting and encouraging same-sex dancing or "alternative lead and follow"
- An excursion to a local competition, introducing dancers to the concept
- A welcome party before one of NASSPDA's sanctioned competition
- Setting up a booth at a local street fair promoting same-sex dancing
- A neighborhood or community event promoting partner dancing and the inclusion of same-sex dancing
- Involving studios to promote same-sex dancing
- An event in conjunction with a city's Pride activities
